



Springvale Homemaker Centre Terms & Conditions of Entry (“Terms”)

‘Win your best-ever kitchen’ (“Promotion”)

1. Participation in the Competition constitutes acceptance of these Terms.
2. This Competition is held at Springvale Homemaker Centre located at 917 Princes Highway, Springvale, Victoria (“Centre”).
3. The Promotion commences on Tuesday 4th September 2018 at 10.00am AEST and closes on Sunday 21st October 2018 at 6.00pm AEST.
4. To enter the Promotion, simply email your name, postcode and contact number to competitions@springvalehc.com.au for your chance to enter the draw to win.
5. By entering the Promotion, you agree you are over the age of eighteen (18) years and consent for your personal information to be included in a database for use in direct marketing by the Centre (consenting to receive the Centre’s direct marketing materials). You can opt out of receiving our direct marketing materials at any time by clicking the “unsubscribe” button at the bottom of any email from the Centre or by contacting the Promoter on (03) 95446363.
6. Entries that are illegible, incomplete or do not comply with the Terms are invalid.
7. One entry per person only.
8. Winners will be determined at random.
9. There are 3 prizes (“Prizes”) and there will be 3 winners only.
10. The Prizes will be drawn at the Centre on Monday 22nd October 2018 at 11.00am AEST (“Draw”).
11. The first entry drawn will be the winner of Prize 1, the second entry drawn will be the winner of Prize 2 and the third entry drawn will be the winner of Prize 3.
12. The Prizes are:

23. The Promoter reserves the right to verify entries and claims for Prizes and reserves the right to disqualify an entrant where the entry process has been tampered with.
